## **What information do we collect about you?**

We may collect and process the following Personal Data about you:

- Personal Data you provide us
  - We collect information about you when you apply for DBACE, when you buy tickets for our events and register your details to receive our newsletters or email updates. We also collect information when you voluntarily complete surveys, provide feedback or request details about DBACE or member events and other services. Website usage information is collected using cookies.
  - If you contact us by phone, e-mail or otherwise, we may keep a record of that correspondence.
  - The Personal Data you give us may include your name, address, e-mail address, postal address, and phone number.
- Personal Data that we may collect about you:
  - We may collect information that your web browser and device automatically provide when you visit our Site including, but not limited to:
    - technical information, including your IP address, login information, browser type and version, browser plug-in types



and versions, operating system and platform, and device type; and

- full Uniform Resource Locators (URL), clickstream to, through and from our Site (including date and time), page response times, and download errors.

- Personal Data about you that we may receive from others:

- We may receive your Personal Data from third parties, including, but not limited to:

- information received from other users of the Site or our services;
    - information provided by credit reference agencies; and
    - information received from law enforcement agencies, or other third parties, in accordance with applicable law.

## **How will we use this information about you?**

We may process your Personal Data for the following purposes:

- processing your membership or orders for events, offers and services in order to process your requests, manage your membership and, if you agree, email you with news updates and information about other products, events, offers or services we think may be of interest to you.



- administering the Site and managing internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- ensuring compliance with this Policy;
- processing carried out in connection with the Deutsche Bank Awards for Creative Entrepreneurs (DBACE), including informing you about the programme, or changes to the programme, *via* either: (i) MeWe Foundation; or (ii) subject to your prior consent, any of our partners related DBACE;
- managing your account and communicating with you about your account;
- improving our Site to ensuring that content is presented in the most effective manner for you and for your device;
- allowing you to participate in interactive features of our service, when you choose to do so;
- improving and developing the Site and our other products and services;
- maintaining and improving the security of the Site and our other products and services;
- carrying out our obligations arising from any contracts entered into between you and us;
- facilitating the DBACE submission and judging process;



- providing you with information, products or services that you request from us, or which we feel may interest you, subject to compliance with applicable law;
- notifying you about changes to our services;
- measuring and understanding the effectiveness of advertising we serve to you and others, and to deliver relevant advertising to you;
- responding to requests from law enforcement agencies;
- compliance with applicable law; and
- any other processing activity described in, or reasonably necessary in connection with the purposes described in, this Policy.

MeWe Foundation will not sell your data to third parties.

## **Cookies**

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. This information is used to track visitor use of the website and to compile statistical reports on website activity.

### **Protection of your Personal Data**

We will implement appropriate technical and organisational security measures, to ensure that your Personal Data is treated securely and in accordance with this Policy.

If you sign up to receive services through our Site, you are responsible for keeping your access credentials for the Site confidential. You must notify us promptly if you become aware of any misuse of your access credentials, and immediately change your password.

You should be aware that the transmission of information *via* the Internet is not completely secure. Although we will take all reasonable and proportionate steps to protect your Personal Data in accordance with this Policy, we cannot guarantee the security of your Personal Data transmitted to our Site over the Internet; any transmission is at your own risk.

### **Storage and accuracy of your Personal Data**

## **Data retention**

We will only retain your Personal Data for as long as we require your Personal Data in connection with the purposes set out in this Policy, except where a longer retention period is required or permitted by applicable law.

## **Transfers of Personal Data to locations outside the EEA**

The Personal Data that we collect from you may be transferred to, and stored at, locations outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff may be engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services. We will only transfer your Personal Data to locations outside the EEA if we have a lawful basis for doing so. By submitting your Personal Data to us, you acknowledge that you are aware of potential transfers of such Personal Data to locations outside the EEA.

## **Disclosure of your Personal Data**

- We may share your Personal Data with recipients within our corporate group, for the purposes of operating our business, operating the Site, or otherwise for the purposes set out in this Policy.

- In the event that we sell or buy any business or assets that are material to the operation of the Site, in which case we may disclose your Personal Data to the prospective seller or buyer of such business or assets.
- We may disclose your Personal Data to third party service providers under a suitable written contract, subject to applicable law.
- If we are under a duty to disclose or share your Personal Data in order to comply with any legal obligation. This may include exchanging Personal Data with other companies and organisations for the purposes of fraud protection and credit risk reduction, to the extent permitted under applicable law.
- We may disclose your Personal Data: (i) in connection with any legal proceedings, or otherwise for the purposes of establishing, exercising or defending any legal rights; (ii) in response to requests by government agencies and law enforcement authorities; (iii) when we believe disclosure is necessary or appropriate to prevent physical harm or material financial loss; or (iv) for the purposes of investigating actual or alleged unlawful activity.





## **Your rights**

You may have the following rights, subject to applicable law:

- the right to request access to, or copies of, your Personal Data that we process (such requests may be subject to a fee of up to £10 if they are deemed excessive);
- the right to request correction of any inaccuracies in your Personal Data;
- the right to object, on legitimate grounds, to the processing of your Personal Data; and/or
- the right to request that your Personal Data are deleted.
